What has happened so far?

The SAVE Start-Ups project team has developed the training course for start-uppers and young entrepreneurs comprising from 7 interactive modules relevant to Industry 4.0. and successfully piloted them in 6 partnership countries – Poland, Spain, Portugal, Cyprus, Slovakia and Lithuania.



More than 200 VET providers, start-uppers, young entrepreneurs and all those interested in Industry 4.0 and the IT sector had the opportunity to be the first to try out the training programme on our platform.

From the 29th to 30th September 2021 the final transnational project partners' meeting took place in Cyprus. Together as a team, we discussed our last steps of the project. On the first day we have successfully delivered final multiplier event where all partners presented their developed modules.

Piloting of free m-learning course

In a free m-learning course start-uppers, young entrepreneurs, VET providers and anyone interested in the digital sector had a chance to try interactive training material on topics such as Internet of things, Circular economy, Cybersecurity, Digital Entrepreneurship, Big Data and much more. First, everyone had the opportunity to test their knowledge by taking a pre-test and after getting acquainted with the material in each module they completed interactive exercises/quizzes.
